USE OF THE ADJACENT LAND FOR EXERCISING DOGS PRIOR TO AND AFTER TRAINING

The Club does not own this land but the Shire Permit our useage of same. However, it only takes one loose dog to start a fight that could develop into an all in brawl with the numbers of dogs that are let run free there. The other problem with dogs running loose is that they may easily knock a child, or adult over. So please members, unless you have got a dog that is up to full Novice standard and is under control whilst off lead, LEAVE YOUR LEADS ON. Remember even the trial dogs are not always friendly to other dogs, and it only takes the right set of events for them to want to join in a melee too. So be kind to your dogs and to other people, keep them under control whilst in the paddock in order that we can all continue to use this facility. If you want to let your dog run free before training, do it on the way somewhere, I DO!

ALL members are required to wear their current membership cards on them whilst in the rings, and failure to do this means a trip to the Secretary's table to get 'spotted' for the day.

The show and trial were held over three days. On Friday in the show ring were minor puppy dog/bitch; also junior dog/bitch. In the trial ring you had novice dog/bitch plus some open dog/bitch. The weather stayed great for the whole three days.

The show started at 9.30a.m., and the obedience trial was scheduled to start at 9.00a.m. but it was 9.45a.m. before anything got started.

In the trials in New South Wales it seems if you don't get a qualifying score in any one of the exercises, the Judge tells you that you can leave the ring. If however, you wish to continue and complete the remainder of the exercises the Judge does not write your marks on the score sheet. This happens in all of the trial rings. If you do not receive a qualifying score before the sits and downs, you cannot complete the rest of the exercises, as only qualifying dogs go into these exercises.

At 11.30a.m. on Friday judging in all rings stopped, for the official opening by the Mayor. The Judges for the show and trial were introduced to the exhibitors. Lunch was then taken until 1.00p.m.

For anyone who hasn't been to a specialist show, be it a National, Championship or Open Parade it is something to see. No matter what the age of the dog be it minor puppy or open dog, you have people running around the outside of the ring calling their dog. Some have whistles and squeaky babies rubber toys just to get their dogs to pull that little bit harder.

We didn't see much of the Obedience trial on Saturday as we were in the show ring. The final judging on Sunday was watched by a large crowd. A dog in the Open class took off top show honours, and he was from Victoria. They judged the Winner of Winners in the Obedience rings, but wouldn't tell who had won till the show had finished. Two from Novice class scored 190 and were awarded excellent medallions. One open dog was sitting on a score of 190 pass but "blew it", by handler's mistake on the three minute sit. She mixed the hand signals up and the dog was starting to drop, so she got hold of the correction chain to stop the dog from dropping. Cost her 30points and missed out on an excellent medallion.

PET LOVERS SEEK REPRIEVE

TOKYO, Mon., AFP -

Japan's animal lovers are opposing the building of an animal protection centre with "gas chambers" able to kill 55,200 dogs and cats a year.

The pet lovers want the authorities to use the money instead on projects to induce pet owners to have their dogs and cats sterilised.

The \$5.8 million centre at Tomisato, in Chiba State, will be one of the largest of its kindin Japan when completed early next year.

Officials explained however, that the new centre was also a hospital for treating sick and wounded animals.

According to the Health and Welfare Ministry, there are an estimated 3.2 million pet dogs in Japan.

The number of pet cats is estimated at up to five million.
