In the last Newsletter I made mention of the World Champion Disabled Water Skier and his faithful friend who was always there to tow him safely back to shore when he had completed his run. Since then, I like many other people have received a letter from the Guide Dog Association of Victoria and I think this is one of the more special stories about the dogs they train.

"Can you imagine saving your best friend by pulling him from a river and guiding him safely to the shore?

I can. Because I do it all the time.

My friend, Kevin, lost his sight after a car accident 14 years ago when he was only 25 years old. Before the accident he owned his own restaurant and was also the chef. He did lots of fun things like playing tennis and squash and going to the beach.

The loss of his freedom was hard to accept. Kevin had to learn a whole new way of living. He gave up the restaurant and went back to Deakin Unversity to study for a Bachelor of Arts, majoring in psychology. Now he is an intern psychologist and the Student Advisor on disabilities.

Kevin and I became "friends for life" when we met at the Guide Dog Association of Victoria six years ago. I am the only greyhound/labrador cross working as a guide dog. Kevin thinks my breeding is responsible for my sensitivity and fitness. But I know all Guide Dogs are pretty smart.

When he was a child, Kevin learnt to water ski. He didn't develop any great confidence or skill, but he could 'stay up'. A few years ago Kevin decided to take up water skiing in earnest.

Now he is a champion!

He has worked his way through the ranks and in July 1993, in France, he was the proud winner of the World Water Ski Championship for 'trick skiing'. He says he loves the exhilaration of water skiing and he enjoys the exercise.

That's where I come in... as soon as I see Kevin fall into the water, I jump in, swim out and guide him back to shore. He thinks I'm a champion too. Even when I'm not wearing my Guide Dog harness and I'm officially "off duty" I'm always ready on the alert watching for Kevin when he's skiing. A Guide Dog never really stops working: it's a life-time commitment.

With me beside him Kevin feels confident and free. He is able to do all the things he loves like going to the beach, going jogging and swimming. We travel to Melbourne on the train and I guide him through the traffic and noise to the Uni."

Makes you stop and think about how remarkable man's best friend really is. It also brings home the message of teamwork. For those of us struggling to get our dogs to an acceptable standard we must remember our dogs DO want to please us. And when they don't, we should question whether we are consistently conveying to them what we would like them to do. Once this is clarified to the dog, we can become a TEAM not two separate entities. We need to remember, there are no bad dogs only bad handlers.


The "Challenge of the West", a Fun-day competition against



#### HANDLING DOG FIGHTS

#### The great leveller



The recent incident which involved the fight between royal corgis has led to many dog owners asking what they should do if their dog is involved in a fight. The following advice, by Dr Roger Mugford who is an animal behaviourist at the Company of Animals, Surrey, England was published in UK's Pet Business World as advice on the problem. We sought a reaction from the Palace to the article and below is its response to Dr. Mugford's advice and comment from a "Royal corgi expert".

\* \* \*

We frequently hear of dogs which will fight to the death and situations where only physical extraction of combatants from the melee can save lives.

However, if owners drag the dogs apart, they run the risk of worsening the bite injuries by turning punctures into elongated gashes.

The risks of bites to the hands are considerable and makes the shaking of many hands on State occasions an unbearable occupation, even with the added protection of long, white gloves.

If that disastrous situation arises where intervention requires extreme tactics, Dr. Mugford recommends the use of the nearest gasfilled ( ${\rm CO}^2$ ) fire extinguisher (!) - the sort used to control electrical or petroleum fires. The combination, says Dr. Mugford, of chill, noise and inert gas 'reliably interrupts dog fights'.

But if it happens that a fire extinguisher is not one of the many items you take to the park for your twice-daily exercise routine, then what should you do when all hell breaks loose (apart from yell, scream and jump up and down and call for the nearest footman)?

The good doctor recommends one or more of the following as procedure:

- (a) be watchful, spot early signs of threatening behaviour, intervene and separate the dogs.
- (b) change the context; leave the room and walk to the garden (hopefully they'll have it sorted out by the time you get back); run away (even better); throw a ball or make a noise (you may have to pull out your cannon for this one fighting dogs do a pretty good job of making a noise themselves); or use a thing called Dog Stop ralarm which is effective at doing the job properly.

  (c) be prepared, equip yourself with devices and equipment (the Grenadier Guards or local Air Force) that will help you separate the dogs. Another of Dr. Mugford's ideas is to keep on hand a one-
- the dogs. Another of Dr. Mugford's ideas is to keep on hand a one-metre square board (easily held under the arm of the pack-gorilla you would need to take along on your doggies' walks) with a hand-hold fitted which can be used to separate the two dogs visually, while someone else (presumably the gorilla) removes them; other items might include a blanket to throw over the offending animals (particularly if they change their minds and engage in more intimate activities).
- (d) keep a tub or bath of water full at the ready so that small dogs can be dunked in it (large dogs will dunk you); or alternatively, have a bucket of water at hand to be thrown at the dogs or a hose which can be easily turned on them.
- (e) disaster management: all the above may still not work (or if it has, you've probably killed the dog) you just might have to

(e)....physically intervene. Oh dear.



Revolting people who are 'professional' dog-fighters use something called "break sticks" which they use to separate their poor, wretched animals, and such things are probably not available to passive pooch lovers like you and me. These low-life use the sticks to prise open the dog's jaws - not for us, thank you very much.

When you do finally get so fed up that you just take the dog by the collar and pull him/her away, make sure that the collar is a strong, wide leather one that won't let you down; grasping for a hold on a flying piece of leg, testicle or tail (and slippery one at that) will not do. Your dog will not be amused.

In summary, Dr. Mugford, says that dog fights are best avoided by adopting sound principals of management, including good socialization of puppies to tolerate and enjoy the company of other dogs. He adds that one should construct sensible social orders (perhaps etiquette training by butlers) within dog packs.

#### ALAS, POOR NELSON

(Another gem from Dr. David Hill writing Pet Topics for the Sun)

As I finished writing last week's column preaching the benefits of feeding bones, Nelson arrived in the clinic to remind me nothing that is to do with animals is ever predictable or straightforward.

Nelson the Labrador was feeling a bit poorly, was reluctant to run and had a very tender tummy.

When I examined him there was a suspicious swelling in his stomach that Nelson did not like me pressing. A few questions soon elicited that Nelson had chomped up a "Superball" that the boys next door had the misfortune to hit over the fence. Some types of hard sponge balls cause enormous trouble if swallowed by a dog. When exposed to the gastric juices inside the animal they expand greatly; quite often resulting in a blockage that needs surgery to correct.

As a general rule, what will fit down the front end of a dog will slip out the back end again. For "Superballs" that rule frequently does not apply.

So we treated Nelson with antibiotics and some drugs to assist him in getting rid of any rubber. An arrangement was made to see him each morning and evening until the problem was either resolved with medication or surgery became necessary.

Over the next couple of days Nelson's condition fluctuated from good to tired. During this time he got rid of just enough rubber pieces to keep me satisfied that my diagnosis and treatment were correct.

When he continued in slow decline we decided to operate and remove the offending rubber ball. The surgery was a great success and Nelson has now gone home looking fit and well, with all systems working and he is starting to put the weight back on.

The only problem with the surgery was that there was no rubber ball causing the problem, rather a nasty piece of bone was the villain. This star shape, with four sharp points, had been slowly "walking" its spikey way towards Nelson's tail punching a series of holes in his intestine as it went. I removed a 30cm length of perforated bowel. An injury the likes of which I have never seen before.

His owner has for 30 years fed his labradors marrow bones with never a problem and tremendous general health benefits. Nelson just had to be the rule-proving exception.

He showed us that, although rare, serious problems can occur from eating bones. He also clearly demonstrated that having enough information to reach a diagnosis is not reason enough to close ones eyes to other possible causes. By producing little bits of rubber he demonstrated just how easy it is, once a diagnosis has been made, to find evidence to support one's opinion.

Nelson is now home and very well.

# GOURMET COOKING FOR CANINES....

#### Ingredients:

500gm wholemeal plain flour 500gm ox liver (par-boiled) 500gm carrots 125gm wheatgerm 125gm bran 500gm quick oats 250gm dripping 2 eggs 2 cup full cream dried milk po

cup full cream dried milk powder 600ml water or stock

Melt dripping in water or stock. Liquidize liver and grate carrots finely. Beat eggs. Add all together. Mix well. A small amount of extra water may be needed if the mixture is too dry. Press into a biscuit or Swiss roll tin about 15 to 20mm thick. Press in With a Pizza cutter, roll out marks to enable the biscuit to be broken to the right size for your dog after cooking. Bake in oven at 170°C for 2.5 hours. Remove and turn over. Return to oven, set at 100°C for a further two hours.

Because ox liver has a strong smell, it is better to cook this at night if possible. The second cooking can be done in daytime. Store in the freezer in small, usable amounts.

(Perhaps these could be made for your dog's special yearly day.)

#### BITS & PIECES

Ear Infections - It is astonishing how many supposedly knowledgeable breeders, owners and exhibitors of long eared breeds neglect their dogs' A great deal of attention is paid to the obvious coat and condition, but despite warning signs of head shaking, face rubbing and scratching, owners seldóm lift the ear flaps to peer inside. The ears are very sensitive, so any accumulation in the ear canal will cause distress. In addition to these signs, the dog may become head-shy, not wanting his face or ears to be touched, or he may even show personality changes.

To determine a bacterial or yeast infection, look for color changes in the ear.

Caring for ears - If necessary, clean inside the ear flap with a small pad of damp, absorbent cottonwool.

Never poke anything in the ear canal - that's a job for the veterinarian. See your vet also if your dog is scratching at its ears.

\*\*\*\*

ACTIVATED CHARCOAL - Activated charcoal is a substance which should be in every dog owner's medicine cabinet. Yet, it has fallen into disuse, perhaps being considered a folk remedy. Activated charcoal absorbs chemicals or toxins and helps to dispel them from the body through the faeces. It is

effective in absorbing a number of chemicals and poisons, including insecticides, rodenticides, household chemicals, toxins formed by eating fermented garbage, as well as some bacterial toxins which result from gastro-intestinal infections.

Although beneficial in many cases, it should no be administered to animals which have swallowed caustic substances. It should also not be given to dogs that are vomiting or seizuring, nor to dogs who are on other medications.

The activated charcoal should be given with a saline cathartic mixed with water and administered with a stomach tube. It usually comes either as tablets or capsules which are available at chemists and can be broken up to make the solution. Charcoal cooking briquettes should not be used. A dog with mild flatulence can be given the tablets without dissolution and the gas often will be dispelled. A dog with symptoms of Cont...

bloat should be taken immediately to the veterinarian, and not given the charcoal as a wait-and-see measure.

#### CARING FOR YOUR DOG

Eyes - To clean around the eyes, use a damp cloth or cottonwoolto wipe away foreign matter.

Nose - A hot, dry nose does not necessarily mean illness; however, a dog's nose will normally be cool and damp.

Breath - Inflamed gums or tartar build-up on the teeth may be the cause of your dog's bad breath. Chewing helps to prevent this build-up - large raw bones, dry food, biscuits or rawhide chews help to keep teeth clean. It's worth having the veterinarian examine the teeth annually at vaccination time and at any time you suspect there are problems - for example, if your dog has trouble eating.


 ${\bf Coat}$  - Frequent grooming (daily for long-haired breeds, once or twice a  $_{{\bf week}}$  for short-haired), combined with correct nutrition, regular worming and regular bathing, will help keep your dog's coat gleaming.

NAILS - Regular walks on hard street surfaces usually keep a dog's nails nice and short; otherwise they may require clipping. This job is best done by your veterinarian. The dew-claws - those little nails part way up the inside of the legs - should be checked as they are not worn down by exercise and can grow into the skin, causing considerable pain.

TEETH - It's a good idea to check your dog's teeth every couple of weeks. Raw bones (never feed cooked bones) and hard biscuits are good for teeth and help to keep them clean.
