For dessert she had scoffed 12 miniature ginger and brandy puddings in lemon sauce, a tub of fresh cream and a box of continental chocolates.

(Just as well Sandy hadn't been taught how to open bottles otherwise she would have been one well pickled pooch!)

LIVER YUM-YUMS FOR THE MORE DISCERNING EATERS

LIVER CUBES

Liquify (ugh) 1 1b liver. For this I use chicken livers in a tub, and use the liquid that comes with it. If you use vacuum packed frozen beef liver, add a tad of water. Add a cup flour, 1/2 cup corn meal, 1 tsp. onion powder, 1 tsp. minced garlic, 1 tsp. garlic salt, and 1 tsp. oregano. Spread on cookie sheet greased with oil (consistency when spreading on sheet should be that of peanut butter). Cook at 350 degrees for 12-15 min. I like to make them $\frac{1}{2} - \frac{3}{4}$ in. thick. Cut up and freeze away. They do not take well to standing at room temp. for long periods of time! So, defrost only what you will use in about two days.

LIVER PIECES

Take a pound of beef liver. Put it in water on the stove, add $\frac{1}{4}$ tsp of garlic powder. Boil for $\frac{1}{2}$ hour. Then remove, put on a cookie sheet or something similar and bake at low heat for another hour or so (200°F) After that, cut up into small pieces. Smells whilst cooking, but keeps wonderfully in the freezer, and the doggies love it. The broth can be used on dry food as an extra treat.

ONCE BITTEN, SO WHY SO SHY? By Dr. David Hill

A woman called seeking advice because her very large dog had bitten the neighbour. She did not want to bring the dog to me or any other Vet. because she'd hear Vets. were very expensive. She did not want to give me her name nor to seek the assistance of a dog training club because she said, Rocky did not like strangers.

All she wanted was for me to give her a few home remedy tips in the fond hope that a few words into a telephone would both salve her conscience and change the doq.

It is imperative that this person seeks professional help NOW! The team of dog and owner need an on-site assessment from an animal behaviour specialist. Telephone advice is not adequate.

There is an urgent need to know why this particular dog is biting. Is the problem one of pure aggression, is it fear biting or related to dominance or territory dispute? The handler must learn how to recognise the dog's body language and how to adequately control th anima1.

The way to obtain assistance is via a referral from the local Vet. Not by picking a trainer from the Yellow Pages. Many of the advertised trainers are excellent, however this particular problem with Rocky is too serious to entrust to anyone whose abilities do not come with an endorsement from a veterinarian.

Rocky's owner is in a heap of legal and moral trouble should this dog offend again. In almost all cases where a dog bite sends someone to hospital the dog has bitten before; usually someone known to the doq.

Private attention is not cheap, dog bites less so. Even more expensive would be losing a legal action where it was successfully argued that the owner knew the dog was likely to bite, had been advised to seek professional assistance and then had knowingly and deliberately ignored that advice. Dogs that kill people are dogs like Rocky.

(Dr. Hill is an East Bentleigh veterinarian, and a regular Herald Sun columnist.)

Editorial note:
One would have to think ROCKY doesn't go to the Vet at all, and may never have met one. Therefore he is not immunised; he is not on heartworm preventative treatment and probably isn't even wormed. Sad state of affairs.

It should be made mandatory that before ANYONE is permitted to own and register a dog that they attend a session {}^{\bullet \bullet}_{\bigwedge} Animal Behaviour conducted by registered Animal Behaviouralists, so that they as owners have some understanding of the nature of the animal they wish to invite into their space. If people are not prepared to spend an hour or two at one of these types of information sessions, how can they expect to be able to cope with a lifetime of cohabitation with that animal? This should then be followed up with Council/Shire/City run programs explaining the requirements of responsible dog ownership, both legally and morally. I further believe ALL dogs should undertake some obedience training no matter WHAT size or WHAT breed.



HOW YOU CAN HELP AT A TRIAL

This information is basically for our new members, but will also remind our "not so new" members of just what is involved in running a Trial.

Geelong Obedience Dog Club is affiliated with the Victorian Canine Association and we will be conducting three (3) Agility and/or Obedience Trials in 1996:-

14 April

21 July

10 November

As there isn't any training on these dates, we do ask our members to help with the preparation where and when they can. It's a good way to show your support for the Club even if you don't intend Trialling, but for those who have entertained the thought, it is a practical way to see what a Trial is all about. Of course, the preparation for such an event begins well before the day:-

WORKING BEES

These are usually held on the two (2) Saturdays prior to the Trial and include such jobs as:-

General cleaning of the Clubhouse - windows, kitchen, toilets, bar, etc.

Clipping around trees and the Chain ring, mowing Sweeping and weeding Cleaning equipment - even some painting at times

Setting up of rings on the second Saturday

The working bees start about 10.00am and even if you can only spare \underline{ONE} hour your help will be appreciated.

STEWARDS

48

We usually require 25 - 30 Stewards for a Trial and this is the best experience if you are considering Trialling. Don't worry if you haven't done if before, you are always placed with an experienced Steward and everyone has to start somewhere. We are hoping to conduct a Steward's Seminar early this year and there are various hand-outs available for you to read.

Agility Stewards (usually 6) are required by 8.00am or a little earlier if you can help set up equipment. Obedience Stewards are required at 11.00am. This allows you time to have something to eat (lunch is provided), meet your fellow Steward and Judge and generally get orgainised. We also require 2 or 3 emergency Stewards incase someone can't make it, but if these Stewards aren't required in the ring, they help out by taking scratchings to the rings and drinks to the Stewards and Judges, etc. Plenty to do!!!



HOW YOU CAN HELP AT A TRIAL (CON'E)

ON THE DAY OF THE TRIAL

There are many areas where the Club needs you support on the Trial Day and again, even $\underline{\sf ONE}$ hours help on the day, certainly eases the workload.

CANTEEN

Besides the usual facilities, we provide lunch for the Judges and Stewards which at the April and November Trial is usually cold buffet style and casseroles in July. Lorraine and Malcolm run our Canteen and there is a list below where you can make their day a little easier:-

Making various salads, platters for April and November or casseroles for July. Desserts and cakes are also welcome. Please deliver to the Club from 7.30am to 10.30am on the day.

Small cakes, slices, muffins, etc for the Cake Stall. Please deliver as above. Also help to man the Cake Stall.

Making sandwiches - help needed for 7.30am to make sandwiches for the Judges and Stewards tables and to sell in the Canteen.

Serving in the Canteen - normal sales of pies, passties, lollies, etc, again even <u>ONE</u> hour will help.

In the two (2) weeks prior to the Trial see Lorraine in the Canteen and let her know what you can bring so she can plan ahead.

VETTING TABLES

One extra person is needed to help with the Vetting - stamp "Pass to ring" on cards after bitches have been checked. Time required - Agility 7.30am to 8.15am approx., Obedience 10.15am to 11.30am.

RAFFLE

If you are one of those clever people who are into ceramics or crafts maybe you can donate something to the raffle or even saleable items to the Cake Stall, but if you are like me, see Wendy Bartels and offer an hour of your time to give Wendy a break or sell Raffle Tickets around the grounds.

CLUB EQUIPMENT SHOP

The shop is usually open all day and Wendy Ganly would certainly appreciate a lunch break.



ASSOCIATE DOGS MUST BE SPEYED OR NEUTERED AND A PHOTOCOPY OF THE VETERINARY CERTIFICATE IS TO ACCOMPANY THE REGISTRATION APPLICATION. THE SECRETARY/OR TRIAL SECRETARY CAN HELP YOU WITH ALL THE APPROP-RIATE FORMS DURING OFFICE HOURS.
